Funding and support information for WA primary producers

This document provides some useful resources and information on loans, programs and support services to assist growers, pastoralists and industry experiencing hardship in challenging times.

Season information

<u>Season 2024: information for WA farmers and pastoralists</u> - seasonally relevant information and management options in broadacre and south-west agricultural areas and the Southern Rangelands of Western Australia.

Options to investigate

Grants, loans and programs

- Interest-Free Loans Applications for the interest-free loans are now open. Farm businesses can apply for \$25,000 to cover the costs of stockfeed, water and transportation. The funds can also be used to establish feed silos, water tanks and improved irrigation systems or any other infrastructure that supports drought resilience. The loan is repayable over 5 years with no repayments for the first 2 years. The availability of loans is subject to funds being available. Applications will close 30 November 2024 (or when funds are exhausted). The loans are administered by the Rural Business Development Corporation and are delivered through the Department of Primary Industries and Regional Development. - <u>Hardship Grants</u> Applications for the \$5000 hardship grant are now closed as funding has been fully committed.
- <u>Drought Loans</u> for eligible farm businesses are available from the Australian Government farm business lender, RIC (Regional Investment Corporation). RIC provides low-interest Drought Loans for farm businesses to help them prepare for, manage through and recover from drought. Farm business loans of up to \$2 million are available. Farm businesses are encouraged to learn more about eligibility and lending criteria before applying.
- <u>AgBiz Drought Loans</u> for eligible small businesses directly linked to the farming sector are available from the Australian Government farm business lender, RIC (Regional Investment Corporation). Low interest loans of up to \$500,000 may help eligible farm-related businesses in drought affected areas manage their business during a drought. Eligibility and lending criteria apply to all RIC loans.
- The Australian Government's <u>Farm Management Deposits (FMD)</u> Scheme is a risk management and drought preparedness measure which allows eligible primary producers to set aside pre-tax income which can be drawn upon when required. Income deposited into an FMD is tax deductible in the financial year the deposit is made. It becomes taxable income in the financial year in which it is withdrawn. FMDs are held by authorised deposit taking institutions and attract market rates of interest. Primary producers can access previously lodged FMDs to supplement business cash flow. This may include accessing deposits held for less than 12 months, for eligible drought affected properties (without penalty).



• The <u>Farm Household Allowance Program</u> is a program of support for farmers and their partners running commercial operations that are experiencing low cash flow. There are four financial components, underpinned by practical support to help people examine their business and make sustainable changes. The \$10,000 Activity Supplement plays a large part in the change process because people can pay for professional advice and/ or training to achieve their goals. Around 18,500 people have accessed the program and the vast majority have said it makes a big difference in the short to medium term. Although the application process is rigorous, most people say it is worth it.

Farm Debt Mediation Scheme

 Available to assist farm and pastoral businesses resolve commercial debt disputes regarding loan agreements with their financial institution. Mediation is conducted by an independent mediator in an impartial and safe environment.  - <u>Disaster Recovery Allowance</u> a short-term income support payment to assist individuals who can demonstrate that their income has been affected as a direct result of a disaster.
